All in-person attendees to both the Pre-Bid Meeting and Bid Opening will be required to adhere to CDC, State and Local COVID-19 related guidelines and procedures. We recommend each interested party send only one representative if desiring an in-person presence.

Virtual attendance to both the Pre-Bid Meeting and Bid Opening will be offered via Zoom. Interested parties must contact the Issuing Office of the Engineer a minimum of two (2) business days in advance of the meeting and provide the necessary contact information to obtain the virtual access information. It is the attendee's sole responsibility to know how to use the Zoom platform and access/attend the meetings accordingly.

The Project consists of the following major items:

Replacement of approximately 7,500 LF of existing 2-inch galvanized iron and PVC waterlines with 6-inch PVC waterline; Replacement of approximately 3,500 LF of existing 6-inch cement asbestos, steel and cast iron waterlines with 6-inch PVC waterlines; Installation of approximately 500 LF of looping of dead-end 6-inch waterlines; and Installation of approximately 27 fire hydrant assemblies, 25 gate valve assemblies and 149 residential water services reconnections, associated appurtenances and associated work.
