- 2. This Agreement constitutes the sole and entire agreement of the Parties with respect to the current and past due Town of Jonesville taxes. This Agreement shall supersede all prior and contemporaneous understandings and agreements, both written and oral, with respect to such subject matter.
- 3. If any term, clause or condition of this Agreement shall fail, be found to be illegal, void, or declared invalid, for any other reason, by a Court or other authority or under the terms of this Agreement, such failure or declaration of illegality, void, or invalidity shall cause this entire Agreement to be and the same shall be null and

void. In the event this Agreement becomes null and void, all promises, and agreements contained in this Agreement shall cease to exist and the Parties shall be free to act accordingly.

- **4.** This Agreement may not be modified or changed except in a writing signed by all Parties.
- 5. This Agreement shall be governed by and construed under the laws of the State of North Carolina.
- **6.** This Agreement shall be binding upon the Parties, their heirs, successors and assigns.
- 7. Except as expressly stated in this Agreement, no Party to this Agreement is relying upon any statement, representation or promise of any other Party not contained herein as a basis for executing this Agreement or making the agreements provided for herein.
- 8. The waiver by any Party of any term, covenant or condition herein contained shall not be deemed to be a waiver of any subsequent breach of the same or any other term, covenant or condition herein contained. Further, failure to immediately act upon a breach of any term, covenant or condition herein shall not be deemed a waiver of such term, covenant, or condition.
