TOWN OF JONESVILLE REGULAR BOARD MEETING MINUTES November 9, 2020

The Town of Jonesville Council met for the Regular Monthly Board Meeting on Monday, November 9, 2020 at 7:00 pm live and via Zoom electronic meeting for anyone wishing to join.

Mayor Pardue called the meeting to order at 7:00 pm followed by the Pledge of Allegiance.

Public Hearing

Mayor Gene Pardue opened the Public Hearing regarding a request for rezoning property located on Osborne Street identified as parcel #122790. The property is currently zoned R-12 and a request is made to rezone to R-MH. Town Manager Michael Pardue addressed the Council regarding the request. The Mayor opened the floor for any member of the public wishing to address the Council on this matter. Questions from the Council were addressed – Council Member Adkins questioned the exact location of the property. The applicant, Mr. Anderson, described the location and adjoining property owners by name.

There were no comments from the Public. The Mayor closed the Public Hearing. A motion was made by Council Member Green to approve the rezoning request for parcel number 122790 from R-12 (Residential) to R-MH (Residential-Manufactured Housing). A second was made by Council Member Wall and approved by unanimous vote. 5-0

Jonesville Trail Association

Chair Toby Butcher updated the Council regarding damage along the Jonesville Greenway Trail from the most recent storms, Hurricane Zetta and flooding on November 12, 2020. Toby presented photos showing before and after damage along the trail.

Finance Director, Wendy Thompson, presented an update before the Council regarding the CARES funding. There is still currently \$7,700.00 available in the utility assistance program. In the event these funds are not used by the citizens the funds will be used to cover the cost of other PPE and supplies purchased by the Town. One hundred percent (100%) of the allotted funds will be expended and a report showing additional purchases above the allotted funds will be reported to NC PRO. Any changes to the current CARES application will be presented to the Council at the December meeting.

A second was made by Council Member Adkins and approved by unanimous vote. 5-0
