Parks & Recreation Board Report – Chair Roger Hurd discussed how the members are meeting monthly and building a strong foundation together. Chairman Hurd expressed his thanks to Tony Anthony, Jason Walker and Kasius Stanley for their effort they put into the community for park and recreation in Jonesville and Yadkin County. He further discussed upcoming volunteer opportunities and meetings.

**Greenway Trails Report** – Chair Toby Butcher presented a power point presentation detailing the 2020 projects along the Jonesville Greenway Trail by volunteers. Chairman Butcher spoke of the time and dedication on the mountain bike trail from TrailSmith Designs and Yadkin Valley Cycling Club. There is current .83 miles in place and will be about 1 mile for the 1st bike trail.
