

## **CHAPTER 99: ADDRESS DISPLAY**

### **§ Section 99-01      PURPOSE AND INTENT**

The purpose and intent of this Ordinance is to make sure all residents and business owners in the Town of Jonesville display accurate identification address numbers in order to facilitate provision of adequate public safety and emergency response services and to minimize difficulty in locating properties and buildings for public service and the general public.

### **§ Section 99-02      DISPLAY OF YADKIN COUNTY ASSIGNED ADDRESS NUMBERS**

Road address numbers must be clearly displayed so that the location can be identified easily from the road.

- (1) The official address number must be displayed on the front of the building or at the entrance to a building which is most clearly visible from the road during both day and night.
- (2) If a building is more than seventy-five (75) feet from any road, the address number shall be displayed at the end of the driveway or easement nearest the road which provides access to the building.
- (3) Numerals indicating the address of a single family dwelling shall be at least three (3) inches in height and shall be posted and maintained so as to be legible from the road.
- (4) Numerals for multiple dwelling units and nonresidential buildings shall be at least six (6) inches in height and shall be placed on the front of the building facing the road or on the end of the building nearest the road.

- (5) Numerals must be of a contrasting color to the background.
- (6) Mobile Home Park lots shall have sequential address numbers throughout the park. Each lot will have a separate address number assigned by Yadkin County. The address number of each lot must be clearly displayed on the lot so as to be legible from the road rather than mounted on the mobile home unit.

The Yadkin County Address Administrator will have the right to authorize and approve alternate methods of displaying house numbers which meet the intent of this Ordinance When strict adherence to these standards cannot reasonably be met.

**§ Section 99-03      ENFORCEMENT**

- (A) No Zoning Compliance permit shall be issued until an official road address has been assigned by the Yadkin County Addressing office.
- (B) Owners or occupants of buildings already constructed which do not comply with this Ordinance will be notified and requested to meet these requirements within 30 days from the date of the notification. A warning notice will be issued after 30 days if the requirements have not been met. If the owner does not comply voluntarily with this Ordinance within 30 days of delivery of a warning notice by registered or certified mail or by hand delivery to the building in violation, enforcement action pursuant to G.S. 160A-175 will be taken. (see Section 1-1006 Use and Penalties)

This Ordinance is effective upon its adoption, this the 10<sup>th</sup> day of July, 2000.
