Public Hearing - Request for Rezoning

Mayor Pro-Tempore Anita Darnell opened the public hearing on a request by NC Farm Bureau. NC Farm Bureau filed a request for a rezoning of property located at 503 Winston Road, parcel #123707 as listed in the Yadkin County Registry to rezone the property from B-2 (Business) to B-2 CZ (Business Conditional Zoning). There were no public comments. The applicant Justin Somers addressed the Council and public stating there would be no change in the exterior of the building except to close in the drive thru. Mostly
