If approved, a post must be placed on the Town website and at Town Hall that the board plans to approve a Resolution to surplus and donate an item to the fire department. After five days of posting this notice, the Council can then approve the Resolution at the next open meeting. After discussion the Council asked that the notice be posted and placed on the next agenda in April.
