Approval of Agenda



- Presented the Council with the Proposed Fiscal Year 2022/2023 Budget.
- Presented the Council with the 2022-2023 Jonesville Economic Development Strategy Update as prepared by the NC Main Street & Rural Planning Center Staff.
- Discussed with the Council an opportunity to apply for grants including a possible 20% match by the Town for the Jonesville/Elkin Pedestrian Bridge. A motion was made by Council Member Green to seek grants and allow the Town Manager to follow up with a letter to the state as well as all parties involved. A second was made by Council Member Green and approved by unanimous vote. 5-0
- Discussed with the Council a Rural Transformation Grant, training & grant opportunity, through the NC Department of Commerce. There will be no cost to the Town for the training. Mileage will be reimbursed. A motion was made by Council Member Green to allow the Town Manager to pursue the RTG, RC2 Grant. A second was made Council Member Wall and approved by unanimous vote. 5-0
- Presented the Council with the 2022 Recreational Trails Program grant award letter. The grant is in the amount of \$100,000.
- Reviewed with the Council the Waste Management contract to begin July 1, 2022 and end July 30, 2027. A motion was made by Council Member Wall to approve the contract with Waste Management of the Carolinas, Inc. A second was made by Council Member Tilley and approved by unanimous vote. 5-0

A motion was made by Council Member Adkins to go into closed session to discuss economic development. A second was made by Council Wall and approved by unanimous vote. 5-0

A motion was made by Council Member Green to go back into open session. Second was made by Council Member Tilley and approved by unanimous vote. 5-0

A motion was made by Council Member Tilley to adjourn the meeting. A second was made by Council Member Adkins and approved by unanimous vote. 5-0
