Payment terms will be negotiated with the selected firm. The fee for grant administration services will be paid with RTG funds.

Scope of Services:

The Town of Jonesville has been awarded a Rural Transformation Grant in the amount of \$900,000 by the North Carolina Department of Commerce (NCDOC). Project Activities include:

- Expansion and Renovation of the Jonesville Public Library

Grant administration services shall include, but are not limited to, standard tasks necessary for the implementation of the project in conformance with the following RTG compliance areas:

- 1.) Environmental Review Compliance and Release of Funds and other Funding Conditions
- 2.) Completion of all required reports and documentation;
- 3.) Assistance with Financial Reimbursements Forms; and
- 4.) Setting up and managing official records;

The services will not include the disbursement or account of funds distributed by the Town's financial office, legal advice, fiscal audits, or assistance with activities not related to the RTG project.

Proposal Submission:

Submissions provided to the Town of Jonesville shall include at a minimum:

- 1. Individual or Firm Information: the consultant or firm's legal name, address, email, and telephone number, the principal(s) of the firm and their experience and qualifications;
- 2. Grant Administration Experience: description of specialized experience and technical competence of the staff to be assigned to the project with respect to grant administration, and description of firm's prior experience, including any similar projects (in particular those funded by NC Commerce), size of community, location, total construction cost, and name of local official(s) knowledgeable regarding the firm's performance. Include at least three references;
- 3. Consultant / Firm Capability: description of firm's current work activities, capability of carrying out all aspects of RTG related activities, and firm's anticipated availability during the term of the project;
- 4. Familiarity with local government.
- 5.. Cost of Services: Indicate a fee for service and explanation of the basis for the fee; and
- 6. Documentation of compliance with state and federal debarment/ eligibility requirements.

Proposal Evaluation Criteria:

Proposals for grant administrative services will be evaluated by a Selection Committee on an equal competitive basis. The following criteria will be used in the evaluation process:
