Double Bluff Master Plan Presentation

Responses from the public were taken into consideration for the master plan. After Mr. Shabeldeen shared a visual presentation and reviewed the master plan including proposed maps outline multiuse of the area for citizens and tourists, Town Manager Michael Pardue requested Council move forward with a Motion to accept the plan. A motion was made by Council Member Green to approve the Double Bluff Master Plan as presented. A second was made by Council Member Wall and approved by unanimous vote. 5-0

Town Manager Michael Pardue then presented a PARTF Grant Resolution for approval by the Town Council. A motion was made by Council Member Tilley to approve the PARTF Grant Resolution. A second was made by Council Member Adkins and approved by unanimous vote. 5-0

Wetherill Engineering FEMA/Jonesville Blvd Culvert Project


Eddie Wetherill with Wetherill Engineering addressed the Council and those in attendance regarding the progress of repairs at the Jonesville Boulevard Culvert.

Business – Michael Pardue, Town Manager

- Presented for review and approval by the Town Council a Resolution for a study project described as Lead and Copper Service Assessment. The project intends to locate and identify lead service lines and/or lead goosenecks within the Town's water distribution system. The resolution allows the Town Manager to execute and file an application on behalf of the Town with the State of North Carolina for a loan and/or grant to aid in the study of or construction of the project. A motion to approve the Resolution for a Lead Pipe Assessment grant as presented was made by Council Member Green. A second was made by Council Member Adkins and approved by unanimous vote. 5-0

- Presented for review and approval by the Town Council a Resolution for Lead and Copper Service Replacement which allows the Town Manager to execute and file an application on behalf of the Town with the State of North Carolina for a loan and/or grant to aid in the study of or construction of the project. A motion was made by Council Member S. Darnell to approve the Resolution for the Lead Pipe Replacement Grant as presented. A second was made by Council Member Adkins and approved by unanimous vote. 5-0
- The Town of Jonesville has two representatives on the Yadkin Valley ABC Board, Regina Adkins and Blake Cheek. Blake Cheek's term is scheduled to end on June 30, 2023. A request was made to appoint Blake Cheek for an additional term of three years. A motion was made by Council Member Green to appoint Blake Cheek to the Yadkin ABC Board for a three-year term beginning July 1, 2023 and ending June 30, 2026. A second was made by Council Member Adkins and approved by unanimous vote. 5-0
- Presented for review and approval the Jonesville North Carolina 2023 Water Shortage Response Plan. A motion to approve the Water Shortage Response Plan was made by Council Member Tilley. A second was made by Council Member S. Darnell and approved by unanimous vote. 5-0
- Presented for review and approve a General Fund budget amendment to reverse funds not being used for a capital outlay purchase. A motion was made to approve the General Fund budget amendment as presented by Council Member Adkins. A second was made by Council Member Tilley and approved by unanimous vote. 5-0
