Mayor Darnell called the meeting to order at 7:02 pm followed by the Pledge of Allegiance.

Consent Agenda - The Consent Agenda was not approved.

Approval of Agenda - Mayor Darnell presented the March 11, 2024, Agenda for approval by the Town Council. Council Member Tilley requested the agenda be amended to include a presentation of a golf cart ordinance for the Town. Mayor Darnell requested the Council approve the ordinance to be placed as item F on the agenda. A motion was made by Council Member S. Darnell to approve the agenda including the amendment, with a second by Council Member Adkins and approved by unanimous vote, 5-0.

Public Comment Period - There was no public comment.

Departmental Reports

Departmental reports were included in the agenda packets and given verbally by the following:

Golf Cart Ordinance – Council Member Tilley handed out a proposed Golf Cart Ordinance for Council, Town Manager, Police Chief, William Buffkin and Town Attorney to review and edit then requested it be added to the next meeting in April for a vote.

Business – Michael Pardue, Town Manager, addressed the Council with the following business matters:

Intergovernmental Agreement with Yadkin County – Chief Mastin has requested an agreement between the Town and Yadkin County which will provide mobile CAD terminal data network to officers with Jonesville. The agreement is for a period of five years with a renewal option. A motion was made by Council Member Green to approve an Intergovernmental Agreement for Access to the Mobile CAD Terminal Data Network between the Town of Jonesville and Yadkin County with a second by Council Member Wall and approved by unanimous vote, 5-0.

NC Land & Water Trust Fund Grant – Town Manager is requesting Council allow staff to pursue opportunities for grant funding to cover a streambank protection project. The request to NC Land & Water will be for \$512,476 and benefit Lineberry Creek at Double Bluff Recreation Area. A motion was made by Council Member Adkins to allow Town Manager to pursue opportunity for grant funding for streambank projection on Lineberry Creek through NC Land & Water Trust Fund Grant with a second made by Council Member Tilley and approved by unanimous vote, 5-0.

Jonesville Recreation Commission – There are currently two seats available on the Commission Board of Directors needing to be filled. The board has a total of seven members. At this time staff requests two board members be appointed by the Council namely: Regina Adkins as the Town Council Member, ex-officio member and Roger Hurd, Town resident as the Chairman.

1. Motion was made by Council Member Green to appoint Regina Adkins as an Ex-Officio member representing the Jonesville Town Council on the Jonesville Recreation Commission effective March 1, 2024, with a second by Council Member Tilley and approved by unanimous vote, 5-0.
2. Motion was made by Council Member Wall to appoint Roger Hurd as Chairman to a 3-year term ending June 30, 2024, to the Jonesville Recreation Commission effective March 1, 2024, with a second by Council Member S. Darnell and approved by unanimous vote, 5-0.

Message from Mayor Anita Darnell - A budget workshop has been scheduled for Saturday, March 30, 2024. With this being a holiday weekend the Mayor asked for any Council members who would like to reschedule. After discussion it was announced that the budget workshop would be held in the Council Chambers on Saturday, March 30, 2024, at 8:30 am. The next regular monthly meeting for the Jonesville Town Council will be Monday April 8, 2024, at 7:00 pm in the Council Chambers at Town Hall.
