

**AN ORDINANCE DECLARING A ROAD CLOSURE FOR  
JONESVILLE – ELKIN CHRISTMAS PARADE**

**WHEREAS**, the Town of Jonesville acknowledges the Downtown Business Association Parade Committee is having the annual Christmas Parade for the pleasure of the citizens; and

**WHEREAS**, the Town of Jonesville acknowledges its citizens realize the benefits from holding an annual Christmas Parade; and

**WHEREAS**, the Town of Jonesville acknowledges a parade requires approximately one (1) hour to install signing and traffic control, and requires approximately (1) for removing signs, traffic control, and litter; and

**WHEREAS**, the proposed street closing and the proposed use of the closed street will not unreasonably interfere with the normal activities of surrounding residents, businesses, or institutions; and

**WHEREAS**, the street proposed to be closed will reasonably and safely accommodate the expected number of persons; and

**WHEREAS**, neither the proposed use nor the anticipated sound or noise level arising from such use will have an unreasonably adverse effect upon surrounding residents, businesses, or institutions; and

**WHEREAS**, the pedestrian and motor vehicle traffic generated by the proposed use can be reasonably and safely accommodated on the streets and walkways of the area surrounding the street proposed to be closed; and

**WHEREAS**, adequate security and crowd control will be provided by responsible public agencies; and

**WHEREAS**, adequate fire control and fire prevention service can be provided by responsible public agencies; and

**WHEREAS**, the proposed street closing and the proposed use of the closed street are not likely to cause an unreasonable danger to the public health or safety; and

**WHEREAS**, the proposed street closing, and the proposed use of the closed street are not likely to unreasonably interfere with public transportation and emergency services; and

WHEREAS, notice of the proposed street closing has been given to interested parties in accordance with the instructions given by the Town Manager; and

NOW THEREFORE BE IT ORDAINED by the Town of Jonesville Board of Commissioners pursuant to the authority granted by G.S. 20-169 that they do hereby declare a temporary road closure during the day(s) and times set forth below on the following described portion of a State Highway System route:

Date(s): The second Sunday of December of each year

Time: 1:00 pm to 5:00 pm

Route Description: *Beginning on S. Bridge Street (Hwy 21) at the intersection of Valley Drive proceeding along North Bridge Street (Hwy 21 Business)*  
*North Bridge Street to Elm Street (Hwy 21 Business)*  
*Elm Street to the Gwyn McNeil Bridge*

This ordinance to become effective when signs are erected giving notice of the limits and times of the parade, and implementation of adequate traffic control to guide through vehicles around the parade route, and approval of the North Carolina Department of Transportation.
