Presentation -

Alex Shelton, with American Tank Maintenance, gave the Board an updated overview of their maintenance program, in which the Town is currently contracted for the water tank locations. Mr. Shelton reviewed photos of the Jonesville water tanks and pointed out changes and updates from the benefits of the full service they offer as a "one-stop shop."

After listening to Mr. Shelton's presentation, there was a discussion about installing a fence for safety measures around the Mineral Springs tank to avoid any trespassing or injury.

Business – Wendy Thompson, Interim Town Manager, addressed the Council with the following business matters:

- 2. Contract with Ferguson Fence for the Jonesville Water Plant
 - A motion to approve the contract with Gregory Ferguson DBA Ferguson Fence and budget amendment allocating \$12,000 from Water Fund Balance was made by Mayor Pro-Tempore Green, seconded by Council Member T. Wall, approved by unanimous vote, 3-0.
- 3. Proposal from The Wooten Company in assisting the Town of Jonesville with grant writing for the Community Development Block Grant Neighborhood Revitalization (CDGB-RV) grant application.
 - A motion to approve the proposal from The Wooten Company and budget amendment allocating \$4,000 from Fund Balance made by Council Member M. Tilley, seconded by Council Member T. Wall, approved by unanimous vote, 3-0.
- 4. Hydrant flow testing equipment for Arlington Fire & Rescue to properly test the flow and pressure from Town fire hydrants
 - A motion to allocate funds to Arlington Fire & Rescue for the purchase of the Little Hose Monster and approve budget amendment allocating \$3,900 from Fund Balance was made by Mayor Pro-Tempore Green, seconded by Council Member R. Adkins, approved by unanimous vote, 3-0.
