A motion to approve the Consent Agenda was made by Mayor Pro-Tempore Green, seconded by Council Member T. Wall, and approved by unanimous vote, 4-0.

Business – Wendy Thompson, Interim Town Manager, addressed the Council with the following business matters:

1. A resolution was made to designate Tiffany Hall-Long as the Deputy Finance Officer, along with updated signatory designations for Anita Darnell, Andy Green, Regina Adkins, and Tasha Ferguson.
 - o A motion to approve Resolution to appoint Tiffany Hall-Long as Deputy Finance Officer and reappoint designated officials to countersign checks and drafts was made by Council Member M. Tilley, seconded by Council Member T. Wall, approved by unanimous vote, 4-0.
2. A Resolution to Rescind Authority Under Grant SRF-D-LSL-0036 to rescind the former resolution approved on November 20, 2023, for the Lead Service Line Replacement project. The current VUR Grant will replace lines over time and, by rescinding the project, will save the Town's water fund \$108,780.
 - o A motion to approve Resolution and budget amendment in the amount of \$21,000 appropriated from fund balance was made by Council Member R. Adkins, seconded by Council Member M. Tilley, approved by unanimous vote, 4-0.
3. Agreement with Neese Dirtworks to grade, stone, and put screenings on the hill just past the covered bridge on the Jonesville Greenway Trail.
 - o A motion to approve Agreement with Neese Dirtworks was made by Council Member T. Wall, seconded by Council Member R. Adkins, approved by unanimous vote, 4-0.
4. Agreement with Ultimate Services to perform work over the coming months to allow for additional building of crossings and other trail improvements in the Spring.
 - o A motion to approve the Agreement with Ultimate Services for trail development was made by Mayor Pro-Tempore Green, seconded by Council Member M. Tilley, approved by unanimous vote, 4-0.
