Mayor Darnell called the meeting to order at 7:05 pm, followed by the Pledge of Allegiance.

**Public Hearing** – Parcel Number 124047 Premier Properties LLC

Mayor Darnell called the public hearing to order at 7:07 p.m.

Town Manager Wendy Thompson presented Council with information for the Conditional Use Permit for Premier Properties LLC for their property at 570 Winston Rd.

Ted Roberts, Owner of Premier Properties LLC, spoke to Council and went into detail about the businesses that will be within the premises. The building will be split into three separate businesses: classic car sales and display, real estate office, and a small bistro.

Due to the absence of Council members, the vote for the conditional use permit and adoption of agenda will be recessed to Friday, March 13, 2026.

  - A. Matthews thanked the Council for keeping the Jonesville Civic Center. A. Matthews had some questions about the fitness equipment and if it would be possible to keep that equipment open for public use.

  - D. Bryant spoke to Council about issues with his water and brought some questions to their attention about which pump station within Town his water is coming from.
- Barry Byrd- 557 Winston Rd., Jonesville
  - B. Byrd brought to Council a request to get the speed limit changed down Highway 67 as coming through the business portion of Town. The current 55 speed limit can be dangerous and a hinderance to customers when pulling out onto the highway.
- Toby Butcher-6300 US Highway 21
  - T. Butcher wanted to share with the Council that he is excited about the Jonesville Civic Center and thinks that it will be a great asset to the Town.
