Mayor Darnell called the meeting to order at 7:02 pm, followed by the Pledge of Allegiance.

Public Comment Period –

No public comment was made.

Presentation –

Michael Silverman, Yadkin County Manager spoke to Council about the proposed Sales Tax increase that Yadkin County is proposing for a vote in this year's November election. Mr. Silverman is seeking that County residents vote to increase the overall sales tax to 7%, that which is the same for neighboring counties to avoid the potential rise in property tax. Mr. Silverman will be hosting two Town Hall forums in Jonesville. The first is on May 14th at 6:00 pm and the second will be on May 21st at 11:00 am.

Emily Ryan with NC State University presented to Council her CORE presentation for Uptown Jonesville and what this could look like in the future. The plans include additional apartment/condo housing along the Yadkin River and the potential for retail, food or hobby businesses as well along the strip near the intended housing would be placed.

A motion was made by Mayor Pro-Tempore Green to recess the May 11 Regular Scheduled meeting by Thursday, May 28 at 7:00 pm., seconded by Council Member M. Tilley, approved by unanimous vote, 5-0.

Reconvene May 28, 2026

Mayor Darnell called the meeting to order at 7:36p.m. and Council Members Michael Tilley and Scott Darnell were absent from the meeting.

A motion to approve the revised Agenda from May 11, 2026, was made by Council Member R. Adkins, seconded by Mayor Pro-Tempore Green, approved by unanimous vote, 3-0.

Business – Wendy Thompson, Town Manager, addressed the Council with the following business matters:

1. A list of 2025 delinquent property tax was given to Council from Tax Collector William Buffkin for approval for late listing advertisement with the Elkin Tribune and Yadkin Ripple newspapers locally.
 - Motion to approve the 2025 Property Tax Advertisement was made by Mayor Pro-Tempore Green, seconded by Council Member T. Wall, approved by unanimous vote, 3-0.
2. A contract between the Yadkin Valley ABC Board and the Town of Jonesville through the Jonesville Police Department was presented to Council regarding NC GS Chapter 18B and expending 5% of profits from Jonesville Police assisting within Surry County's Town of Elkin to be paid annually in November of each calendar year.

- Motion to approve the contract with Yadkin Valley ABC Board was made by Council Member T. Wall, seconded by Council Member R. Adkins, approved by unanimous vote, 5-0.
- 3. A Resolution was brought before Council to receive two viable utility grants for water distribution and water plant rehabilitation projects that will be funded through the State of North Carolina Department of Environmental Quality Division of Water Infrastructure in the total amount of \$14,961,500.00 for both projects, VUR-D-ARP-0057 and VUR0D0ARP-0058. This Resolution also will allow the Town Manager to approve on behalf of the Town of Jonesville but only within the limit of the original grant funding amount.
 - Motion to approve the Resolution to receive two viable utility grants from the State of North Carolina Department of Environmental Quality Division of Water Infrastructure was made by Council Member R, Adkins, seconded by Council Member T. Wall, approved by unanimous vote, 3-0.

Town Manager W. Thompson reviewed the proposed Fiscal Year 2026-2027 Budget with present Council for any questions or concerns they may have.

A motion to adjourn the reconvened meeting was made by Council Member T. Wall, seconded by Council Member R. Adkins, approved by unanimous vote, 3-0.
