Mayor Darnell called the meeting to order at 7:05 pm, followed by the Pledge of Allegiance.

**Consent Agenda** - The Consent Agenda included the following:

A motion to approve the Consent Agenda was made by Council Member S. Darnell, seconded by Council Member M. Tilley, approved by unanimous vote, 5-0.

A motion to approve the Agenda for June 8, 2026, was made by Council Member R. Adkins, seconded by Mayor Pro-Tempore Green approved by unanimous vote, 5-0.

### **Public Comment Period –**

- Roger Hurd – 125 S. Bridge St, Jonesville, NC
  - R. Hurd opened with letting Council know he loved NC Trail Days and the events the Town organized. Afterward he expressed concern to Council about the construction in progress by the Yadkin Valley Sewer Authority along South Bridge Street in Town limits. He spoke on his belief that their work was being performed incorrectly and the obligation of after work cleaning up has not been taken care of. This has left the residents through that area with a mess in their yard or driveway and put safety at risk by the loose gravel in the roadways.

- Mack Bowers – 255 N. Mineral Springs Dr, Jonesville, NC
  - M. Bowers gave public comment toward the end of the meeting before adjournment but wanted to speak to Council about an issue with a three-way stop sign on North Mineral Springs Drive that part of the public are disregarding and driving through unsafely. He requested information on a petition for a speed bump on his street in Town to help correct the issue by slowing drivers down.

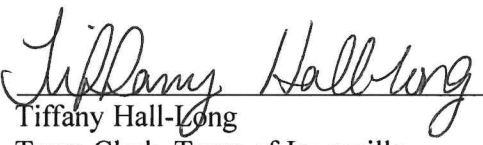
**Presentation –**

Town Manager W. Thompson presented an updated mission statement for the Town along with the recommended fiscal year 2026-2027 budget to Council for final review and questions or concerns. The public hearing for the adoption of the Fiscal Year 2026-2027 Budget Ordinance is scheduled and advertised for Tuesday, June 30, 2026, at 7:45 pm.

**Business –** Wendy Thompson, Town Manager, addressed the Council with the following business matters:

1. Resolution for NC DOT Easement request for drainage/utility from the Town of Jonesville across property known as Surry County Tax Parcel 495118424054 currently owned by the Town of Jonesville and Town of Elkin as tenants in common.
  - A motion to approve the Resolution for NC DOT Easement made by Council Member T. Wall, seconded by Mayor Pro-Tempore Green, approved by unanimous vote, 5-0.
2. NC Commerce offered the Town an additional amount of \$1,522,760 for the CDBG-CV Grant for the purpose of demolition and construction of a multi-use court at Lila Swaim Park and a budget amendment was presented to include these grant funds into the Budget Ordinance.
  - A motion to approve CDBG-CV additional funds letter dated June 3, 2026, was made by Mayor Pro-Tempore Green, seconded by Council Member T. Wall, approved by unanimous vote, 5-0.
  - A motion to approve Budget Amendment for the CDBG-CV Grant as presented was made by Council Member R. Adkins, seconded by Council Member S. Darnell, approved by unanimous vote, 5-0.
3. A revision of the current Town Ordinance Chapter 92 for the Recreational and Parks Regulations was discussed with the Board to include operating hours for Sergeant Gregory Martin Park and Double Bluff Recreation Area and penalties for violations of Ordinances.
  - A motion to approve the First Reading of Revisions to the Recreational and Parks Regulations Chapter 92 under Town Ordinances was made by Council member T. Wall, seconded by M. Tilley, approved by unanimous vote, 5-0.
4. A special event permit was presented to the Board for the upcoming Kickoff Party at Unique Transportations for Rally in the Valley, which will take place Friday, August 7, 2026. Council Member M. Tilley recused himself from voting on this business matter.
  - A motion to approve the Special Event Permit for Unique Transportations' Rally in the Valley Kickoff Party was made by Council Member S. Darnell, seconded by Council Member T. Wall, approved by unanimous vote, 4-0.

A motion was made to adjourn was made by Council Member M. Tilley, seconded by Council Member R. Adkins, approved by unanimous vote, 5-0.
